## **Entirely Redesigned Transit System Proposed In DART Forward 2035 Recommendations Released Today**

The Des Moines Area Regional Transit Authority today releases the DART Forward 2035 Recommendations, which propose an entirely redesigned transit system for Greater Des Moines to better serve the growing population throughout the region.

The recommendations call for streamlining and improving frequency on many of the bus routes already in place today as part of the core network. New routes have been added in areas, while some existing routes have been identified for restricting or discontinuation. New services being proposed for the next 10 years include suburban circulators in West Des Moines and Ankeny, high-frequency service along University and Ingersoll avenues between downtown Des Moines and 42<sup>nd</sup> Street, expanded Express routes, more service to and between major retail centers, and eventual cross-town service connecting the east and west sides of the metro area without being routed through downtown. Five corridors have been identified for possible enhanced transit services. In addition, the recommendations identify possible expansions in service beyond year 2020, such as Express service to cities on the outermost perimeter of the metro area, as well as to and from Ames.

“This is what we have been steadily working toward since we created DART out of the MTA in 2006,” said Angela Connolly, Polk County Supervisor and Chair of the DART Commission. “We wanted to turn the city bus agency into a truly regional transit system. These transitions take time, of course. In the past five years we have taken thousands of steps – some small, some giant – to position the agency for smart, sustained expansion to meet the increasing demands of a growing, thriving metro. Today, we are pleased to be presenting the public with a bold proposal for transforming transit as we know it.”

DART wants the public to review the recommendations and give their feedback before a DART Forward 2035 Transit Services Plan is finalized this fall. Nine public meetings have been scheduled throughout the metro this week (the schedule is below). The DART Forward 2035 Recommendations were developed with input from more than 1,300 members of the public through their participation in an online survey and four public meetings in April. The public made clear that they want more investment in public transit. They identified three priorities: They want service in more places, with more frequency and faster travel times.

The DART Forward 2035 Recommendations also take into account the four guiding principles that the DART Commission adopted in May. The Commission directed staff and the consulting team to develop a plan that builds a network based on market demand, to refocus the service network to generate the best possible return on investment, to enhance customer service, and to build financial sustainability.
